## RULES AND REGULATIONS OF POSTGRADUATE (MD/MS) ADMISSION IN JNIMS, IMPHAL-2023-2024

### 1. Duration of courses:

<b>MD/MS</b>	The course will be of 3 (three) years from the date of admission and 2 (two) year those with recognized two years P.G. Diploma holders in the same subject

### 2. Eligibility Criteria:

Candidate must be an Indian national holding MBBS degree or equivalent from Medical College / Institute recognized approved by Medical Council of India (MCI) / National Medical Commission (NMC) of India and has obtained permanent registration from NMC or any State Medical Council. In the nomination letter, any directive/option of subject preference mentioned against the names of candidates will not be entertained as the allotment of seats will be strictly done in order of merit of the National Eligibility cum Entrance Test (NEET PG-2023).

### 3. Categories of Postgraduate Seats:

There are two categories of Post-Graduate seats available in Jawaharlal Nehru Institute of Medical Sciences, Imphal:

(A) Sponsored Category

(B) Open Category

### 4. In-Service Sponsored Category:

- (i) Ordinarily, candidates working in the State Health Services (Health Cadre) or JNIMS on regular basis only will be considered.
- (ii) Ordinarily, candidates who are appointed on temporary/contract basis or ad-hoc appointment are not considered under the 'In-Service Sponsored Category'.
- (iii) Admission for the sponsored candidates will be cancelled at any time if they have been admitted in the postgraduate course by submitting false information or documents.

### 5. Open Category:

- (i) Open Category: Candidate must be a domicile of Manipur holding MBBS degree from any recognized Medical College / Institute/ University recognized by MCI/NMC. And has obtained permanent registration from NMC or any state Medical Council.
- (ii) Open Category (JNIMS Product): Candidate must be an Indian national holding MBBS degree from Jawaharlal Nehru Institute of Medical Sciences (JNIMS) Imphal and must have obtained permanent registration from NMC or any state Medical Council.



**(iii) Who are not eligible:**

- (i) A candidate can apply either in In-Service Sponsored or Open Category. Candidate who applies in both In-Service Sponsored and Open Categories for the same academic session shall not be eligible for counselling.
- (ii) Candidates, who have already obtained an MD/MS Degree from Manipur or any other University in India.

**6. Submission of Application Form:**

- (i) A candidate seeking counselling for admission is required to submit his/her application in the prescribed form only.
- (ii) The candidate should fill in the application form in his/her own handwriting, clearly and legibly. Application form should reach the Office of the Dean (Academic), A-Block, Jawaharlal Nehru Institute of Medical Sciences, Porompat, Imphal – East, Manipur – 795005 **on or before 11<sup>th</sup> August, 2023 till 2:00 PM.** **Application (s) received thereafter shall not be entertained under any circumstances.** JNIMS, Imphal will not be responsible for any delay.  
*Further, request for extension of last date for submission of filled in application form through proper channel for the In-Service sponsored candidates shall not be entertained. The State Government is hereby requested to follow the timeline to avoid future conflicts.*
- (iii) PG Counselling application form submission fee Rs. 2,500/- (Rupees Two Thousand Five Hundred) only.
- (iv) The Counselling Fee is Non-Refundable.
- (v) Incomplete application forms shall be rejected and no correspondence will be made by the Institute in this regard, Complaints received after the last date of submission of applications will not be entertained.
- (vi) Applications for all In-Service sponsored and In-Service applying for Open Categories candidates should be submitted through their respective state health service authority.
- (vii) Application forms for the candidates in the sponsored category should be countersigned by the concerned authority as per state government policy.

**7. Selection Process:**

It will be strictly based on the marks obtained in the NEET –PG-2023 Examination and selection will be purely on merit basis.

Vacant seats of In-Service sponsored and Open categories after counselling will be allotted to the waitlisted eligible candidates after making a common pool of merit list separately for In-service sponsored and Open categories respectively based on the merit of the NEET-PG-2023 examination in subsequent counselling. Cross-over of In-service sponsored and open categories or vice-versa is not allowed.



*Candidates who are not eligible / qualified in their respective categories shall not be considered for selection.*

**8. Inter-se-merit of candidates obtaining equal marks:**

In case of two or more candidates obtaining equal marks in the NEET-PG-2023 the inter-se-merit of such candidates shall be determined in order of preference as follows:

- (a) Having higher rank in NEET –PG-2023
- (b) Seniority, in case of In-Service candidates
- (c) Minimum number of attempts in MBBS Examination
- (d) Candidate securing higher percentage of marks in Final MBBS Examination (Part-I & Part-II combined)
- (e) Older candidate will be given preference over younger one.

**9. Counselling:**

Tentative date for counselling will fixed later on and notified. Candidates are required to be physically present with all relevant original documents. Choice of subject as allotted on the basis of personal counselling will be final and no request for subsequent change of subject or mutual exchange of subjects will be entertained after the last counselling.

*Candidate who does not participate in the first counselling will not be eligible for any subsequent counselling.*

**10. Documents to be examined during counselling:**

- i. Acknowledgement slip issued by JNIMS, Imphal on submission of the prescribed form for PG seat in JNIMS, Imphal
- ii. Admit Card of NEET – PG- 2023
- iii. Score Card in NEET – PG- 2023
- iv. University MBBS Degree Certificate.
- v. Mark sheets of MBBS Examination (1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> Pt-I & Pt-II)
- vi. Attempt Certificate
- vii. Internship Completion Certificate.
- viii. Permanent NMC / State Medical Council Registration Certificate.
- ix. Domicile certificate

**Venue of Counselling:** To be announced later.

**11. Admission :**

List of the selected candidates will be published soon after counselling. The candidates are required to get themselves admitted on or before the notified date by paying the necessary fees and submitting the following documents in original to the Office of the Dean (Academic), Jawaharlal Nehru Institute of Medical Sciences (JNIMS), Imphal:

- a) Permanent NMC/State Medical Council Registration Certificate
- b) Mark Sheets of MBBS Examination (1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> Pt-I & Pt-II)
- c) University MBBS Degree Certificate
- d) Admit Card of NEET – PG- 2023
- e) Score Card in NEET – PG- 2023
- f) Attempt Certificate
- g) Internship Completion Certificate
- h) Permanent NMC / State Medical Council Registration Certificate
- i) Aadhar card/Pan card
- j) Domicile Certificate



**12. Joining:**

Candidates should join for duty to the concerned Department on the date that will be announced later.

**13. Contract:**

On admission, all original certificates & other necessary documents of candidates will be retained in the Dean (Academic) Office, JNIMS, Imphal. The same will not be returned to the candidate before completion of the course. For their own convenience, one set of Xerox copies of the documents may be retained by the candidates. A security deposit, fixed from time to time, is to be made if the student wishes to withdraw these documents for a limited period of time related to appearance of interview etc. during the course.

Candidates who does not join the MD/MS course after getting admitted or leaves the said course within the First year of joining shall be liable to pay a sum of Rs. 3,00,000/- (Rupees Three Lakh) only, whereas candidates who leave the course after one year of joining shall be liable to pay a sum of Rs. 7,00,000/- (Rupees seven Lakh) only as compensation for such midstream departure. In such cases, the original certificates will be returned only after payment of the penalty. In addition, for the candidates admitted under the Open Category, they are also liable to return the cumulated salary received from JNIMS, Imphal over and above the penalties mentioned above.

An undertaking to this effect is to be submitted in the prescribed format by the concerned candidate at the time of admission.

Postgraduate students who changed the institute or the subject in the subsequent counselling shall not be entitled for the part salary for the duration he or she worked before leaving or changing a subject in JNIMS, Imphal.

**14. Salary/Stipend for open In-Service candidates:**

Ordinarily, salary/stipend for the In-service candidates admitted under open category shall not be paid by the Institute. However, it may be considered base on the merit of the case.

**15. Anti-Ragging Policy:**

Ragging is a punishable crime in JNIMS, Imphal under UGC and NMC guidelines.

**16. Accommodation:**

Attempts will be made to provide hostel accommodation to all students. However, usual wait period may range from 0-4 months. Students are to arrange their own accommodation during the wait period. Married accommodation facility is not available in the campus.

**17. Jurisdiction:**

Any dispute arising out of selection of postgraduate students will be decided by the Post-Graduate Selection Committee of JNIMS, Imphal.

**However, any legal dispute pertaining to selection of postgraduate students shall fall within the jurisdiction of High Court of Manipur, Imphal only.**
